## IN CASE YOU DID NOT KNOW.....

## **2 REASONS TO DONATE TO MDH-PAC**

<u>Public Act 161</u>, 2005 is legislation passed with the intent of providing access to dental care to under served populations. The registered dental hygienist is one of several "entities" who may apply to the State of Michigan for this status. Once received, the applicant can either provide preventive dental care or be employed by the entity who owns the PA 161 status to provide the care to those in need.

To date there are over 100 RDH who enjoy this status and several programs where the registered dental hygienist holds the PA 161 status. Several thousand patients are being seen who were not before. Application of this law are primarily schools and nursing homes but many other opportunities exist as well. A dentist may own the PA 161 status, a nursing home may own the status, or a hygienist may own the status.

This law waives the requirement in statute that a patient must be first seen and treatment planned by a dentist before receiving treatment from the hygienist. This allows the hygienist to see many otherwise not seen and make appropriate referral if necessary. Dental homes are sought where appropriate. The hygienist must work under the supervision of a dentist although the supervision may be and generally is, off-site.

This law is providing competent professional care provided by licensees of the state of Michigan who are responsible to the Michigan Board of Dentistry and is proving to be a safe, efficient, exceptionally high quality of care for citizens of the State of Michigan.

- 7 ASSISTING A DENTIST OR DENTAL HYGIENIST WHO AT THE TIME IS ACTIVELY
  - PERFORMING SERVICES IN THE MOUTH OF A PATIENT, MAY FUNCTION AS A
  - SECOND PAIR OF HANDS FOR THE DENTIST OR DENTAL HYGIENIST.

Four Quadrants: A DH Digest

This presentation will highlight four personal and professional topics of interest to dental hygienists and the dental team. Information focusing on key information and trends will be provided related to the Michigan Administrative Rules and Michigan Medical Records Access Act. In addition, patient provider communication and interpersonal relationships will be reviewed including social media and health literacy.
